### A. U.S. Department of Education Definitions:

- Homeless: Lack of fixed, regular, and adequate housing
- Unaccompanied: Not living in the physical custody of your parent or guardian
- Youth: 21 years of age or younger

2. At any time on or after July 1, 2016, did the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and Urban Development (HUD) determine that you were an unaccompanied youth who was homeless or self-supporting **and** at risk of being homeless?
  - Yes If yes, **you must submit a letter from the Director of HUD.** The letter must be on official letterhead, explain the determination that was made, and be signed by the Director.
  - No If no, please review **Question 3.**
  
3. At any time on or after July 1, 2016, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or self-supporting **and** at risk of being homeless?
  - Yes If yes, **you must submit a letter from the Director.** The letter must be on official letterhead, explain the determination that was made, and be signed by the Director.
